Action

1 Police Report

CPO Alan Richardson reported that in the last two months 20 calls had been made to the police, none of which were crime related. 5 were youth related. There had been 2 house disturbances and 1 crime involving vandalism to a house. 2 calls were made to report suspicious persons. 1 arrest was made for drunk driving.

The No Cold Callers initiative, piloted in Ayton, is to be continued up the A1 corridor.

There had been 2 accidents on the B6355 near Peelwalls Cottage corner. MC reported that a site meeting with police, SBC representatives and residents is to be arranged as soon as possible. Ayton Primary School had been vandalised recently.

The police focus for the next months is tackling travelling criminals.

3 Residents from Whitfield enquired about the CC's responsibilities and views regarding the proposed Blackmains wind farm. They explained their objection to the project. MC explained various aspects regarding wind farms in general in the SB area and that the CC has a responsibility on behalf of the community to assess the planning application on its merits. The CC has a second responsibility to ensure that, in the event of the application being successful, it has done all it can to maximise any developer contributions to the local community.

ENERTRAG, the company involved with the wind farm is holding a meeting for the general public in Ayton Community Hall on Thursday 6th October in the afternoon and evening.

- **Edinburgh Buses via Ayton** MC reported that Richard Perryman of Perryman's Buses had not yet been available for discussion. MC will continue to try to arrange a meeting as soon as possible. It was noted that First Bus was withdrawing its Berwick – Edinburgh service early in October.

- **Christmas Lights** BHA had agreed to a dedicated metered supply from Clock Tower House. RB is investigating the cost of this. SBC is investing £400,000 over two years to provide safe connections for festive lights. We may be able to use some of this funding.
